In addition to signifying peer recognition of the student's scientific accomplishment, the award includes a registration fee waiver for the SRA Annual Meeting, a plaque and an honorarium. Key aspects of the paper may include: practical difficulties of making effective risk management decision advice in the real world, effective ways you found to address those difficulties, any evidence that your organization's/client's risk management has improved due to your analysis/advice, interesting metrics you used to assess that improvement, lessons learned and paths forward. You can include procedural devices (e.g. Red Teams, External Review) but please no papers limited to procedural devices only. We especially encourage papers developed, in whole or in part, by "real world" risk managers.

Risk Policy and Law Specialty Group Wants to Support Your 2017 Annual Meeting Presentation

Please reach out to this year's group chair, [Kirk Hartley](#), no later than Monday, May 15, if you have a proposal you would like the RP&L group to consider, as we intend to support one or more presentations at SRA 2017. The RP&L group is also interested in collaborating with other specialty groups on panels that cross group lines.

Examples might include risk analysis strategies for rapidly emerging technologies (e.g. AI diagnostics), or risk analysis for susceptible populations (e.g. persons in certain age groups or with inherited genetic mutations that some may argue will leave them "more susceptible to low dose toxins" in the workplace). Note also that the amended TSCA "scoping" documents are due out on June 19 and likely will provide fertile grounds for risk analysis topics. Finally, last week's US House vote on health care, and other related draft bills, highlight the re-emergence of issues regarding risks related to the growing abundance of genetic information, and how to understand, manage and regulate (or not) personal, financial and other risks related to health conditions and genetic data.

Each month the Communications Committee selects an article from the journal for further media coverage. Last month's selected article featured a new study on airport security procedures.

Study Reveals What Air Travelers Will Tolerate for Non-Discriminatory Security Screening

Mounting anti-terrorism security procedures and the Transportation Security Administration's (TSA) screening processes have launched numerous debates about the protection of civil liberties and equal treatment of passengers. A new study published in Risk Analysis has successfully quantified how much potential air passengers value equal protection when measured against sacrifices in safety, cost, wait time, and convenience.

The study, "Valuing equal protection in aviation security screening," examined how much American travelers valued the principle of equal protection by quantifying the "equity premium." The equity premium included the following components: monetary costs defined as a screening fee that passengers were willing to pay per flight; wait time defined as the length of time in minutes that passengers had to wait to complete security screening; convenience defined as the proportion of passengers without contraband who are mistakenly singled out for further scrutiny; and safety defined as the acceptable percentage of passengers who board with contraband that was not detected during screening (known as the "miss rate").
